Vote-by-Mail for Endorsements in Our Club? By Greg Valtierra

At our May meeting a motion by Alan Corlin was passed by the members directing the Executive Board of the Club to look into the feasibility of conducting our endorsement votes in the club with mail-in ballots. The board started the discussion of this issue at the board meeting on May 24.

A primary motivation for moving to mail-in ballots is to increase the participation of all our members in the decisions for endorsement in our Club. Additionally, it is hoped that the mail-in ballots could generate more interest in our endorsements and perhaps add additional legitimacy to the endorsement decisions of the club. Obviously, a change of this sort will be a departure from past practice in the Club and there may be some obstacles that would need to be overcome to be able to implement mail-in procedures.

As President, I have appointed a sub-committee to look at the benefits, obstacles, and costs of implementing mail-in ballots. The sub-committee will be making it's recommendation to the board which will in turn make a recommendation to the general membership at a future general meeting, possibly in July or August.

At our upcoming meeting this month one of the discussion topics in our workshop will be the interest in and feasibility of adopting vote-by-mail. I encourage all of you to attend and provide your input on this issue. If you can't attend the meeting you can still provide your input by

Since these groups will take advantage of the standard Yahoo Groups capabilities, members will be able to choose whether they continue to receive messages from the list and how often they receive the messages. It will also be possible to view the messages online so that you could choose not to receive messages but could still see what's going on. Please keep an eye out for messages from these two lists.

Meeting Start Time Will Change by Greg Valtierra

At the recent board meeting on May 24 the board has decided to move the start times for the Club's general meetings to start a half-an-hour earlier. Starting with July's meeting we will have the Call To Order at 7:00 PM. Refreshments will available at 6:50 PM. Our main program or speaker will still begin as before at 8:00 PM. Previously our General Meetings have begun at 7:30 PM with refreshments available at 7:00 PM.

After some discussion the board agreed to try this new start time to enable the body of members to complete more of the Club's business before the main topic of the evening. The board hopes that this change will avoid the problem of having members leave the meeting before all the club business is taken care of and depriving the Club of the quorum necessary to conduct business. Another hoped for benefit will be an earlier adjournment of the meeting to allow everyone a chance to get home at a slightly more reasonable hour.

Changing Our Club Constitution by Greg Valtierra

In order to keep up with changing circumstances every so often our club has made modifications to our constitution. The Club's constitution currently restricts the club to modifying the constitution no more than once a year and requires a 2/3 vote of the members present at the meeting.

There are a number of items that have been suggested at recent Executive Board meetings as amendments to the Club's constitution. The first item is one of necessity. According to the rules of the LA County Democratic Party, which is the chartering organization for our club, our constitution must provide for a waiver of our membership dues for financial hardship. Currently, we list the option of asking for a waiver of dues on the membership form in the newsletter but we don't have specific language for this in the constitution. This language will need to be added.

Two other related items have been suggested regarding our endorsement votes. The constitution requires a second ballot for endorsement if there are still open seats in an election which do not have endorsements after the first ballot. One suggestion has been to use Instant Runoff Voting procedures to allow this second ballot to be conducted simultaneously with the first. This would shorten the time needed to conduct a vote endorsement and would need only one ballot sheet to conduct the two ballots. A second suggestion is to remove the requirement for a second ballot and base our endorsements solely on a single ballot. Both of these suggestions could affect the feasibility of conducting a vote-by-mail endorsement process and if the club chooses to implement such a process it is likely that one of these two options would need to be implemented to make vote-bymail possible.

Another amendment that has been discussed pertains to the number of members required for a quorum. The constitution requires a minimum of 25 members and 3 board members present at a general or special meeting to form a quorum allowing the club to conduct business. A few years ago this number was lower. Within the last year or two we've had a few instances where we fell short by one or two members for the quorum requirement and we had to stop conducting Club business. The change of meeting time discussed earlier in this newsletter is intended to avoid problems with the lack of a quorum so this item is not likely to be considered at this time.

I will be appointing a subcommittee to provide language for amendments to the constitution to be considered at our August meeting. If you have other items you'd like to have considered for amendments to the Club's constitution please submit them to me in writing or by email at President@CCDemClub.Org.
