The Federal Reserve

The Federal Reserve System was created in 1913 because our economic system would have its highs and lows. The Democrats wanted it to be controlled by the government, but the banks and the Republicans dug in their heels to create a quasi-government system. The purpose and functions of the Federal Reserve Bank include:

Preventing banking panics
To serve as a central bank for the
United States

- To strike a balance between private interests of banks and the centralized responsibility of government. (To do this they must supervise and regulate banking institutions)
- Protect the credit rights of consumers
- To manage the nation's money supply through monetary policy such as maximum employment, stable prices, moderate long-term interest rates.
- Maintain the stability of the financial system and containing systemic risk in the

financial markets.

A Board of Governors was established to be responsible for supervising the private banks.

The recent depression was not caused by the Federal Reserve Bank but it made it worse by contracting the money supply per Milton Friedman and agreed to by Ben Bernanke, the present Chair of the Federal Reserve. They did nothing to restrain the banks from their predatory tactics in the present housing crisis. State Attorney-Generals around the country tried to sue the banks but were stopped by the Federal Government. The Green Party as part of their platform wants the government to place the Federal Reserve System under the Secretary of the Treasury.

Club member Ruth Weisman was the recipient of the prestigious "Pat Eastman Volunteer of the Year" award on August 3, 2008 at the Queen Mary site of the Los Angeles County Democratic Party Award night of "Democrat of the Year" And we congratulate her.

Final Two State Propositions for November:

There are now twelve propositions that have qualified for the November ballot, plus a local measure for the Community College District. At our July meeting we took positions on 5 of them. In August we took positions on 3 more along with the Community College Measure. That means we have 4 propositions to take positions on. Summaries of Propositions 9 and 11 have already been published in previous newsletters and discussed at Augusts' meeting. Additionally, Proposition 1 which we voted on at our July meeting has been replaced by proposition 1A due to legal requirements. Proposition 1A may not be finalized until September 18 but we will discuss the current version of the Proposition in anticipation of no further significant changes.

The following summaries have been excerpted from the California Secretary of State web site. More detailed information is contained on the Secretary of State's web site at http://www.sos.ca.gov/elections. The positions taken on these propositions by the California Democratic Party (CDP) have also been indicated.

#7 - Renewable Energy Generation. Initiative Statute:

CDP Position = No

Requires utilities, including government-owned utilities, to generate 20% of their power from renewable energy by 2010, a standard currently applicable only to private electrical corporations.

- Raises requirement for utilities to 40% by 2020 and 50% by 2025.
- Imposes penalties, subject to waiver, for noncompliance.
- Transfers some jurisdiction of regulatory matters from Public Utilities Commission to Energy Commission.
- Fast-tracks approval for new renewable energy plants.
- Requires utilities to sign longer contracts (20 year minimum) to procure renewable energy.
- Creates account to purchase rights-of-way and facilities for the transmission of renewable energy.

Summary of Legislative Analyst's Estimate of Net State and Local Government Fiscal Impact:

Increased state administrative costs of up to \$3.4 million annually for the regulatory activities of the California Energy Resources Conservation and Development Commission and the California Public Utilities Commission, paid for by fee revenues.

Unknown impact on state and

local government costs and revenues due to the measure's uncertain impact on retail electricity rates. In the short term, the prospects for higher rates—and therefore higher costs, lower sales and income tax revenues, and higher local utility tax revenues—are more likely. In the long term, the impact on electricity rates, and therefore state and local government costs and revenues, is unknown.

#12 - Veterans' Bond Act of 2008:

CDP Position = Not Considered

- This act provides for a bond issue of nine hundred million dollars (\$900,000,000) to provide loans to California veterans to purchase farms and homes.
- Appropriates money from the state General Fund to pay off the bonds, if loan payments from participating veterans are insufficient for that purpose.

Summary of Legislative Analyst's Estimate of Net State and Local Government Fiscal Impact:

Costs of about \$1.8 billion to pay off both the principal (\$900 million) and interest (\$856 million) on the bonds; costs paid by participating veterans. Average payment for principal and interest of about \$59 million per year for 30 years.
