Addressing the Current Economic Mess

By now, anyone who hasn't lived in a cave over the last several months, knows that the economy is in terrible shape. Major banks and financial institutions have declared bankruptcy or have been taken over by other financial institutions (i.e. Merrill Lynch by Bank of America). Freddie Mac and Fannie Mae have been taken over by the federal government. Unemployment is at a 5 year high.

Property values have declined, and foreclosures are at the highest level since the great depression.

In response to the current economic crisis, congress considered and rejected a \$700 billion bailout of the very financial institutions that are responsible for the "subprime lending" fiasco. Many working people struggling to pay their mortgages and send their kids to college have expressed resentment that congress would be willing to bailout millionaire bankers while no one is helping them with their own economic problems.

What is the economic solution that addresses the needs of working people?

There are many things that need to be done. As a society, we need to end the predatory lending practices that led to the economic meltdown in which we now find ourselves.

Risks associated with certain types of mortgages must be clearly disclosed. Congress should draft legislation requiring that high risk loans be restructured to make them more affordable for working families. In addition, the taxpayer should have an ownership interest in the companies whose bad debts are ultimately purchased in any future bailout plan, should these financial institutions become profitable in the years ahead.

Amendments

As has been announced at several meetings and in previous newsletters there are several amendments to the Club's constitution that have been submitted for consideration. We will be discussing and voting on them at the October meeting. Here is a summary of what has been submitted:

- Submitted by the Board: Amendment to Article IX Section 3 to have language describing our policy for waiving of dues for financial hardship.
- Submitted by Diane Rosenberg: Limit on publication of member roster to Executive Board only.
- Submitted by Eric Fine: Change definition of quorum to use members eligible to vote instead of members in good standing.
- Submitted by Karlo Silbiger: Change the threshold for endorsement of ballot measures from simple majority to 60% just like endorsement of candidates.
- Submitted by Karlo Silbiger: Changes in the structure of club officers and standing committees to focus efforts on political issues.

The Executive Board has reviewed these and has recommendations to adopt some and not others of the submitted amendments. In addition, for the items the Board is recommending, the Board has developed suggested language to adopt. These recommendations and language will be available at the October meeting and will be posted on the Club's web site before the meeting. Report from Club Absentee Voting Subcommittee

The findings of the Subcommittee on Absentee Voting Procedures for the Club which met on August 9, 2008, were presented at the September General Meeting. The committee discussed each of the elements required to implement absentee voting or vote-by-mail for candidate endorsements within the Club. The committee voted on suggested procedures to implement such a program. The full report was made available at the September meeting and will be posted on the Club's website.

The Executive Board reviewed the findings of the subcommittee at the Board Meeting on August 30 and created a consolidated set of recommendations on procedures to implement absentee voting if the membership votes to allow absentee voting for candidate endorsements.

However, the Board was split on whether to recommend allowing absentee voting and 7 members voted against allowing absentee
