#### No Consensus on **Endorsement for the Special Election for** Senate District 26

At our General Meeting on February 11 the Club hosted a candidate forum for the Special Election for State Senate District 26 The candidates in attendance were Robert Cole, Mike Davis, Saundra Davis, Jon Friedman, Curren Price. The remaining Democratic candidate Mervin Evans did not attend.

All the candidates were given time for an opening statement. After the opening statements our President, Ronnie Jayne asked the candidates questions which had been submitted in writing during the meeting by the answer session was completed each candidate was allowed a closing statement.

The Club then heard comments on the vote for endorsement from many members. After the comments the first ballot was closed and had the following results:

Total valid ballots cast = 66. Saundra Davis (30), Jonathan Friedman (16), Curren Price (11), Robert Cole (4), Mike Davis (4), Mervin Evans (0), No endorsement (0).

No one met the 60% requirement of 40 votes for endorsement.

Total valid ballots cast = 65. Saundra Davis (35), Jonathan Friedman (12), Curren Price (10), Mike Davis (4), Robert Cole (2), Mervin Evans (0), No endorsement (2)

No one met the 60% requirement of 39 votes for endorsement.

Our Club's constitution specifies that no more than two ballots can be conducted for an endorsement so no further ballots were taken and the Club has no endorsement for the State Senate Special election. The board urges each of you to take a careful look at the qualifications, experience and positions of each candidate and vote on Tuesday, March 24.

### From the Editor: State Budget Madness

Our elected state leaders have just completed passing a budget for the state of California after a long and drawn out series of negotiations between the Democrats and Republicans in the State Senate. As I'm sure you know, because of Proposition 13 our state is one of only three in the United States that requires more than a simple majority of our State Assembly and Senate to raise taxes. We have a state government in which 1/3 of our elected representatives can hold the rest of the state hostage until their demands are met.

In this case Democratic leaders were forced to make several major concessions and accept drastic cuts in funding for programs aimed at the most vulnerable members of our society, the children, the disabled, the sick and the elderly. Despite the huge deficits that are expected over the next two years in the state budget, Republicans continued to push for tax cuts and further reductions in state services.

Our state is already near or at the bottom of funding for public education per capita. Our public health system continues to experience emergency room closures and diminished services. The state continues to underfund maintenance of our transportation, water, and energy infrastructure. In other words in just about every area our state and local governments don't have enough money to go around and the Republicans at the state level want to squeeze spending even more.

It's past time that we begin to work on changing this insane system. Despite what Republican leaders may say, our state is not a high tax state. With a state economy that would rank well within the top ten economies of the world if counted separately from the United States there is plenty of room to fund the services and programs we need. Closing loopholes on corporate taxes, asking mining, oil, timber and others benefiting from our states natural resources to pay a fair share, and asking the highest earners in our state to share more of the burden would provide the income we are currently missing.

However, until we change the 2/3 rule to raise taxes we have very little chance in making any progress on providing the revenue a modern state budget requires. We must press our Democratic leaders to make changing the 2/3 requirement a priority. If we want our state to continue to be a leader in prosperity and innovation we can't afford to let the Republican ideologues continue a tyranny of the minority. Enough is enough!
