Why am I, a resident of Culver City and a member of the Culver City Democratic Club, supporting a candidate for Los Angeles City Council?

There are two reasons why I have taken this course of action: (1) because some of our members live in West Los Angeles and (2), and most important, because developments to the north of our community can have a profound effect on traffic congestion in Culver City. For example, the Westfield expansion proposal would expand the Century City Mall by adding over 300,000 square feet and

would include a 39 story mixed use tower. The Casden Project located at Pico and Sepulveda would include 576 apartments, 1,200 additional residents, and 11,000 more car trips. Both developments could have a significant adverse effect on traffic congestion in Culver City.

Anyone who has spent any time observing the Los Angeles City Council knows that the council is heavily influenced by big developers and special interests who make generous contributions to candidates for city council. Of the two candidates running in the Fifth Councilmanic District, Paul Koretz and David T ("TY") Vahedi, who have made it to this May's runoff election, only Vahedi refuses to accept contributions from developers and billboard companies. Moreover, Vahedi has been aggressive in standing up to big developers and in calling for reduction in major projects such as the Casden Project.

Vahedi is a lifelong resident of the Fifth District and has been active in his homeowners association and in various forms of grassroots activism. Unlike some of the candidates he ran against, Vahedi is not a "carpetbagger" or a shill for major developers.

For the above reasons, I support Vahedi for Los Angeles City Council in the Fifth District and encourage my fellow club members to do the same.
