Japanese citizens is just one example of some of the bad decisions made during those crises.

Nevertheless, I am optimistic that we can work through the challenges facing us if we are willing to understand that the solutions won't come without some cost. For too long as an electorate we've wanted services but haven't been willing to provide the funding needed for them. We want our elected leaders to create solutions but have tied their hands in requiring an unreasonably high majority to raise funds to implement them. We vote for special funding that sequesters money for special purposes but ignore the many other essential programs that must be cut back or eliminated because they don't have special protection.

It is only when we assert the power we've always possessed to make the choices in favor of the common good, to look beyond our own special interests and promote the welfare of us all that we will find the means to overcome the challenges we face.

Endorsements at April Meeting

The club held a very spirited and informative meeting on April 15 to discuss the Club's endorsements for the Special Election on May 19.

First Assembly member Curren Price gave an overview of each of the ballot measures that will be on the May 19 ballot and an explanation of how these items resulted from the negotiations for the State budget. Price stated The current State budget has a \$40 billion deficit. To reconcile, cuts in social services programs were made, and some taxes were raised. The budget now provides \$14.9 billion in spending reductions, \$12.5 billion in new taxes and \$7.5 billion in new programs, leaving a shortfall of up to \$17 billion. The 5/19 Election includes propositions to balance the budget.

After Price discussed the budget he also discussed some of the legislative priorities he was working on. Price also answered questions from the audience on the ballot measures and his pending bills in the assembly.

Once Assembly member Price

finished his presentation Darryl Cherness made a motion to endorse Price for the Senate District 26 seat which will be decided in a run-off with the Special Election on May 19. Tom Camarella seconded the motion. Price was endorsed unanimously by the members in attendance.

Once the endorsement for the Senate had been completed the club began discussing motions for endorsements on the ballot measures for the Special Election. Ruth Weisman reported that the LA County Central Committee made the following endorsements on the ballot measures: 1A - Neutral. 1B - Support, 1C - Support, 1D - Oppose, 1E - Oppose, 1F -Support.

Greg Valtierra moved to support measure 1F which was seconded by Tom Camarella. After discussion the motion carried with 1 vote opposed.

Lee Sanders moved to support measure 1A which was seconded by Greg Valtierra. After some heated discussion the motion carried with with 13 ayes, 6 nays, and 2 abstentions.

endorse measure 1B seconded by Lee Welinsky. After the discussion with participation by many members the motion carried with 14 ayes, 1 nav and 4 abstentions.

Lee Sanders moved to support measure 1C, seconded by Bill Wynn. After discussion the motion failed to reach 60% of the vote with 10 ayes, 7 nays, 5 abstentions. No further motion was made on this measure.

Karlo Silbiger moved to oppose measure 1D, seconded by Roger Maxwell. After another lively discussion the motion carried with 14 ayes, 6 nays, 2 abstentions.

Tom Camarella moved to oppose measure 1E, seconded by Karlo. After more discussion the motion carried with 14 ayes, 5 nays, and 3 abstentions.
