Give Elections Back to the People

Is America still a democracy? Yes, but this experiment in self-governance is on life-support. For eight years, we watched our civil liberties deteriorate, our infrastructure collapse, our environment polluted, and our wealth stolen by greedy financiers. Financial ruin has angered and frustrated many citizens. In 2008, we elected a new Democratic President, elated by the possibility that the change we so desperately needed would finally come to pass.

Nearly two years later, unemployment and underemployment remain stubbornly high - the effects of the worst financial crisis since the Great Depression. The military has begun withdrawing from Iraq, only to have increased its presence in Afghanistan - a conflict we can't afford to wage. Despite having brought us from the brink of financial collapse, signing into law sweeping healthcare legislation, and ushering in a massive stimulus plan that saved thousands of jobs, President Obama is getting hit with criticism from the left and right. They complain he's just not doing enough.

A lot of progressives have threatened to abandon Obama and the Democratic Party because they didn't push for single-payer healthcare, or they didn't do enough to rein in the banks, or because they are continuing the wars in the Middle East, or because they haven't done enough to push for gay and lesbian rights, or because the administration still supports oil drilling, or...or...or...

But what is the alternative? Running to a third party? Our winner-take-all electoral system makes it impossible for third parties to be viable. Staying home the next election? That only ensures Republicans get back into office and finish off the country for good. No, the answer is to recognize that the system is broken, get involved in movement politics to

change the system, help elect more progressive Democrats, participate in the Democratic Party and help it adhere to liberal values.

Recognize that Obama and the Democrats are working up against a determined, obstructionist and destructive opposition, the likes of which is perhaps unprecedented. Corporate power and corporate cash is the main reason why an aggressively progressive agenda can't get through Congress - no matter how hard we push Obama. Too many legislators are being bought by Big Business in the form of campaign cash, and that corporate influence burrows its way into legislation.

It's become too expensive for the average person to run for higher office, and so our Congress is turning into a millionaires club. Wealthy former executives like Carly Fiorina and Meg Whitman are literally trying to buy their way into office. The Supreme Court's ruling this year in Citizen's United vs. Federal Election Commission enshrined into law the misguided assertion that corporations are "persons" with the right to engage in and influence the political process. Now, corporations can spend billions of dollars to defeat a candidate or block progressive legislation.

Suddenly, the electoral playing field got even more tilted in favor of those with money. Too many Americans feel their vote simply doesn't count. We must turn this around. In the meantime, we can continue to push for public financing of campaigns. But, in the long run, we must overturn the Supreme Court by demanding a constitutional convention and amend the Constitution to strip corporations of the right to "personhood" and the right to influence the people's elections. We must end the canard that "money equals speech."

No one person or organization should be able to spend unlimited amounts of money to buy their way into public office. It's called public office for a reason. This effort will take a long time and a lot of work, writing letters and calling our local, state and federal representatives to support an amendment. The Culver City Democratic Club and clubs across California and the country should pass resolutions in support of an amendment. We should work to get the state Democratic Party officially on board. An effort to abolish corporate personhood is already underway on the Web called Move To Amend, http://movetoamend.org.

Wallowing in despair because we aren't getting everything we want when we want is not an option. Turning against President Obama and the Democratic Party because you believe they aren't doing enough isn't fair and it isn't wise. Obama has only had 18 months in office. It took 40 years for the Republicans to dismantle much of the New Deal and get the public to buy into their ideology. It may take progressives another 40 years to undo the damage.
