General Meeting – June 8, 2011 Update on Obama Health Care Reform Law with Dr. Michael Cousineau



Since the early 1900s when California voters implemented the statewide initiative process, our state has

systematically used this progressive reform to weaken the power of our elected officials. We instituted the recall holding politicians accountable. We instituted the 2/3 rule for increasing taxes and passing budgets forcing Sacramento to find consensus in all fiscal matters. And more recently, we took away the power of our elected representatives to draw political district boundaries. instead turning that over to an independent redistricting commission.

Democratic leaders, including our Club, opposed the redistricting reform because of the potential to create more moderate seats and the equal representation of Democrats and Republicans on the commission. However, the voters overwhelmingly disagreed, boiling over with frustration after decades of gerrymandering and the creation of so many safe seats

Regardless of our individual feelings about the 2011 redistricting process and its merits, it behooves us as active citizens to become involved to ensure that Culver City's interests are heard as the lines are drawn. Our city currently sits right on the border between 3 assembly districts: the 47th to the east (which includes Ladera Heights and View Park), the 41st to the north (which includes Santa Monica and Malibu), and the 53rd to the west (which includes Mar Vista, Venice, and the South Bay). It is guite possible that Culver City could end up with representatives with whom we are unfamiliar.

The good news is that the process has become more open with this redistricting reform. Instead of lines drawn by the politicians and their political advisors behind closed doors, the redistricting commission has been holding hundreds of public hearings to gather testimony from all those who want to be heard. Report on May's Meeting

The Culver City Democratic Club's May meeting featured a panel discussion on one of the most pressing issues of our time: energy policy. The B.P. oil spill, the Fukushima nuclear meltdown, increasing recordbreaking weather, and ongoing wars in oil-producing countries have created a "perfect storm" of energy-related events..

Around 40 attendees listened and asked questions of the speakers from local, national and international environmental groups. We introduced the topic by showing the short film "300 Years of Fossil Fuels in 300 Seconds" narrated by Richard Heinberg of the Post Carbon Institute. The film shows that in the span of just a few human lifetimes, we have become completely dependent on fossil fuels with disastrous effects on human health. It asks the question, "Where do we go from here?"

Exploring the energy policy problem from different angles, the panelists provided various answers to this question.

Panelist Brian Treanor:



After pointing out the technological challenges of meeting today's energy demands without adding carbon to the atmosphere,

Director of Environmental Studies at Loyola Marymount University Brian Treanor said that political action is the key to combating climate change.

Panelist Dr. Jimmy Hara:



Dr. Hara, Vice-President of Physicians for Social Responsibility recounted his family's

experience as victims of the atomic bomb. A physician, he has extensively studied the science behind both long and short-term nuclear radiation. He underlined the dangers of nuclear arms and energy, letting audience members

Culver City Needs a Motion Picture and Television Museum

As residents of Culver City, we take great pride in our city's motion picture and television heritage. This, more than anything else, defines our community and distinguishes us from other cities throughout the nation. After all, it was here, in Culver City where the Wizard of Oz and Gone with the Wind were filmed. It is here, in Culver City, where Wheel of Fortune and Jeopardy are taped and broadcast throughout the nation, to be viewed by millions of American households.

Given our city's rich history as a motion picture and television center, you would think that our community would go "all out" to promote our history and let the world know about our past. Unfortunately, this is not the case. We, as a community, have done very little to promote our heritage. We have the "Filmstrip USA" sculpture in front of the Veteran's Memorial Building, the Culver City Historical Society Archives and Resource Center that is open 4 hours a month, and is the best kept secret in town; and, of course, our City motto: "Heart of Screenland." That's all we have. We can do better.

Culver City needs a full time, full fledge motion picture and television museum. Such a museum would put Culver City "on the map" and bring thousands of tourists to our city; tourists who would patronize our downtown restaurants, stay at the Culver Hotel (thus generating bed tax revenue), and watch plays at the Kirk Douglas Theatre.

The beauty of the museum is that it would generate multiple sources of revenue for the city. Not only would it bring additional business to downtown, but it would also generate revenue on its own. For example, the city could impose an entertainment fee on the admission to the museum. If the museum had a gift shop selling motion picture/TV memorabilia, the city would receive a portion of the sales tax revenue on each sale. There would be bus tours to the museum, and the operators of those tours would pay a business license fee to Culver City.

Michael R. Cousineau is Associate Professor of Research in the **Department of Family Medicine** and Preventive Medicine at the USC Keck School of Medicine. His research focuses on access to care for the low income uninsured population, operation of safety-net providers including public hospitals and community health centers; and health needs of homeless people. He has studied the impact of initiatives designed to expand health insurance to adults and children, the dynamics of insurance coverage decisions by small businesses, alternative governance of safety net hospitals, and the health and mental health needs of the homeless. His publications appear in American Journal of Public Health, Medical Care. Public Health Reports. Evaluation Review and the Journal of Community Health.


