To the conservative element in this community I have a simple message: you lost, deal with it!



I was surprised at the anger from people who got up to speak against the election of Megan Sahli-Wells as vice mayor. I learned previous city councils had voted to establish a "policy" providing that the offices of mayor and vice mayor would be rotated by seniority once a year. So far, so good.

But then I learned that the city charter provides for the election of the mayor and vice mayor by the city council.

icy had been followed, the city charter would have been violated. The council members have a legal right to elect the mayor and vice mayor. To take away that right is to disenfranchise the council members—at least when it comes to the question of who will be mayor and vice mayor.

Since rotating the offices of mayor and vice mayor violates the city charter, the policy should not have been established in the first place.

It looks to me like the anger over this issue is being stoked by those whose chosen candidates lost the April 10 city council election. I've seen two front page editorials on the subject in a local paper that endorsed the losing candidates.

There are serious problems in Culver City that the council will have to confront: fracking and oil drilling in our neighborhoods, problems with schools, housing, traffic, clean water and clean air. There are serious disagreements among our citizens over how to solve these problems. Let's not get distracted by manufactured disputes.

Also, we should attend city council meetings and speak out when we see good council members being attacked for doing their jobs.

Rules for Elections and Endorsements

Only members of the Culver City Democratic Club, meeting one of the following two criteria, are eligible to vote.

1) A continuing member whose dues were current for the 2017 membership period and has paid for the 2018 membership period prior to the vote.

OR

2) A new member (or a lapsed member) who has joined and paid their dues for 2018 by no later than 25 days before the meeting.

Those eligible will be given ballots if a written ballot is needed.

Voting for club officers and endorsement of political candidates shall be by secret ballot unless waived by two thirds of the eligible voters present. When a club officer position is uncontested, the club may elect the officer by acclamation if there are no objections to such a vote. Endorsements of ballot measures do not require a secret ballot.

An endorsement must have at least sixty percent of the vote. Blank ballots will not be counted in the total.

If a first ballot does not result in an endorsement for all open seats, a second ballot shall be conducted. Only one ballot will be held to endorse ballot measures and propositions.

During the question and answer period for candidates all questions shall be submitted in writing to the chair. Questions should include the name of the person asking the question and should be as legible as possible.

Since we want as many member and non-member comments as possible during the discussion periods, all comments will be limited to one minute or less. Please have your thoughts ready so you can take the fullest advantage of your strictly enforced sixty seconds. Speakers will be asked to line up to make their comment and the comments will be heard in the same order as the order of the line.

Please understand that we are trying to allow as much commentary from everyone as is possible in a very short time frame and appreciate you adhering to these reasonable rules.
