President's Message by Pete Rockwell

LA Supervisor candidate Holly Mitchell will be the speaker at our October meeting

There are four Democrats running for County Supervisor in District 2. Over the last three months the Club heard from Jan Perry, Sharis Rhodes, and Herb Wesson. This month we will have State Senator Holly Mitchell as our featured speaker.

Ranked choice voting

Members attending the September general meeting had a long discussion of ranked choice voting as the Executive Board envisioned it working in our candidate endorsement process. We decided to have a mock election at this month's meeting on October 16. We will vote on various flavors of ice cream and mark the ballots with first, second and third choices. Then we'll count the ballots, so that we all have a better sense of how it works.

Can we endorse Bernie Sanders?

Los Angeles County Democratic Party Chair Mark Gonzalez was scheduled to attend the September 11 general meeting of the Club, to answer the question of whether the bylaws of the Culver City Democratic Club prohibit the endorsement of Bernie Sanders because the Club may only endorse "registered Democratic candidates."

On the day of our meeting I got a call from Devin Osiri, the Executive Direc-

tor of the county party. He apologised for the fact that Mr. Gonzalez would not be able to attend our meeting because an emergency situation had arisen. He asked if we would like Mr. Gonzalez to attend a future meeting.

I told him that the question we wanted to ask was whether the Club could endorse Bernie Sanders without risking the loss of the Club's charter or violating the Club's bylaws.

Mr. Osiri told me that we are free to endorse any candidate on the ballot in the March 3, 2020, California primary because all the candidates on the ballot have been approved by the Democratic National Committee. They have also been approved by the national party to participate in the presidential primary debates.

Impeachment time has arrived

As I sit here putting together the Club newsletter, Nancy Pelosi was just on the news announcing that the House would launch a formal impeachment inquiry in response to the dispute over Trump's efforts to pressure Ukraine to investigate Joe Biden.

I was in my late twenties when Watergate happened, and I was able to listen to almost all of the hearings on the radio while I was working. I think the impeachment of Donald Trump is going to happen, probably before the end of this year. The hearings, if they are anything like the Watergate hearings, will be historic and complicated. I hope millions of people watch.

He'll never be convicted

The United States Constitution requires a *two thirds* vote in the Senate to remove from office a President who has been impeached. This vote is supposed to come after a trial in the Senate. The judge in that trial will be the Chief Justice of the United States.

I'm not completely certain there will be a Senate trial of Donald Trump, even if he's impeached. I wouldn't put it past Mitch McConnell to refuse to hold a trial at all, in order to protect Republican senators from being forced to vote whether or not to remove Trump. I still believe the House of Representatives should not be afraid to impeach him.

Ballot Disclose Act lives to fight another day

A few meetings ago, our Club voted to support SB636 – the Ballot Disclose Act. This bill, authored by Senator Henry Stern and sponsored by the California Clean Money Campaign, requires the ballot label of every state ballot measure to include a short list of official supporters and official opponents so every voter sees this important information when and where they need it most.

The good news is that, despite all opposition, SB636 will live on to become a 2-year bill. The California Clean

Fun with Ranked Choice Voting

At our October 16, 2019, Club meeting we plan a mock election conducted under our Club's adaption of Ranked Choice Voting. In our make-believe scenario, our Club is to endorse one flavor of ice cream. Of course, as in any Club endorsement, a flavor must receive 60 percent of the vote to win.

First Ballot

Members in good standing will sign in as they arrive for the meeting and will receive a ballot like the sample ballot above. Mark your ballot with an "X" in the "First Choice", "Second Choice", and "Third Choice" columns corresponding to your first, second and third choice flavors.

Our vote counters will tally the vote, while the rest of us watch. The counters begin by sorting all ballots by first choice. If any flavor receives 60 percent of the vote, that flavor wins, and we're done.

If not, in the second tally they 1) eliminate the lowest vote-getter and 2) count the second choices of the ballots that had, as a first choice, the flavor that was eliminated. In this way, it is the flavor that is eliminated, not the ballot.

If a voter's first and second choices are eliminated, that voter's third choice becomes their first choice. This process continues until we've run out of candidates and choices.

When this is done, if any flavor has 60 percent of the vote, we have a winner.

Second Ballot

If the first ballot does not result in a flavor receiving 60 percent, we will have a second ballot.

The second ballot is a contest between the two top vote getters. If neither receives 60 percent of the vote, there will be no endorsement.
