President's Message by Pete Rockwell

Ben Grieff of Evolve California will speak on the Schools and Communities First ballot proposition

At our May 13 meeting, the Club will vote on whether to endorse the *Schools and Communities First* ballot proposition.

Despite being the fifth largest economy in the world, California's schools rank in the bottom ten nationally.

For the last four decades, California's schools and communities have lost out on \$150 billion because of a giant corporate loophole in our property tax system. Chevron alone is pocketing over \$100 million a year because they are still paying property taxes based on what their land was worth in the 1970s. This has to change.

The Schools and Communities First ballot proposition is the result of a statewide, grassroots campaign to close the corporate loophole. This common-sense initiative will generate \$12 billion a year for our schools and communities while maintaining protections for all residential property owners.

Our tax dollars should pay for worldclass schools and thriving neighborhoods. Instead, the corporate tax loophole embedded in 1978's Proposition 13 has drained billions of dollars from our local schools and communities for over 40 years. Schools and Communities First will reclaim billions of tax dollars every year for our schools and local communities by closing the loophole in corporate property taxes that benefits a fraction of wealthy corporations and investors. Schools and Communities First will: in revenue for our schools and local communities by assessing commercial and industrial property at fair market value.

NOT raise taxes on homeowners or renters, while leveling the playing field for businesses.

HELP small business by eliminating the burdensome business personal property tax.

ENSURE transparency and accountability for all revenue restored to California's schools and local communities.

One of the organizations responsible for obtaining the signatures necessary to qualify *Schools and Communities First* for the November 3 ballot is Evolve California, an organization that believes the most effective way to counter the corrupting power of money in politics is a long-term commitment to ground-up, grassroots organizing.

"Schools and Communities First" is now called "The California Tax on Commercial and Industrial Properties for Education and Local Government Funding Initiative"

The California Tax on Commercial and Industrial Properties for Education and Local Government Funding Initiative has qualified to appear on the ballot in California as an initiated constitutional amendment on November 3, 2020.

A "yes" vote supports this constitutional amendment to require commercial and industrial properties, except those zoned as commercial agriculture, to be taxed based on their market value, rather than their purchase price.

A "no" vote opposes this constitutional amendment, thus continuing to tax commercial and industrial properties based on a property's purchase price, with annual increases equal to the rate of inflation or 2 percent, whichever is lower.

On April 2, 2020, the campaign *Schools and Communities First* reported filing 1.7 million signatures. At least 997,139 signatures are needed for it to be valid.

Continuity of Democracy



Share your comments with the Council on-line with the new "ecomment" feature. To submit, go to www.culvercity. org/agendas and click on the highlighted eComment link. The ballot initiative would amend the state constitution to require commercial and industrial properties, except those zoned as commercial agriculture, to be taxed based on their market value. In California, the proposal to assess taxes on commercial and industrial properties at market value, while continuing to assess taxes on residential properties based on purchase price, is known as split roll.

Proposition 13 (1978) requires that residential, commercial, and industrial properties are taxed based on their purchase price. The tax is limited to no more than 1 percent of the purchase price (at the time of purchase), with an annual adjustment equal to the rate of inflation or 2 percent, whichever is lower. According to the state Legislative Analyst's Office, market values in California tend to increase faster than 2 percent per year, meaning the taxable value of commercial and industrial properties is often lower than the market value.

The ballot initiative would create a process in the state constitution for distributing revenue from the revised tax on commercial and industrial properties. The ballot initiative would distribute the revenue to specific areas, rather than the General Fund. First, the revenue would be distributed to (a) the state to supplement decreases in revenue from the state's personal income tax and corporation tax due to increased tax deductions and (b) counties to cover the costs of implementing the measure. Second, 60 percent of the remaining funds would be distributed to local governments and special districts, and 40 percent would be distributed to school districts and community colleges (via a new Local School and Community College Property Tax Fund).

Ben Grieff of Evolve California to speak at May 13 general meeting

Ben Grieff is the Campaign Director for Evolve California, a non-profit organization based San Francisco that he helped found in 2011. For the last 7 years Ben has led Evolve California's campaign to restore funding for California's public schools by reforming Proposition 13. His work has helped change the political narrative around a once untouchable issue that is the root cause of California's public education system falling to the bottom ten in the nation in per student funding. Ben sits on the Executive Committee of the historic *Schools and Communities First* initiative that will appear on the November 2020 ballot. This initiative will reform the commercial side of Prop. 13 and reclaim \$12 billion a year for California's schools and communities.

The following resolutions were passed unanimously at the April 22 general meeting of the Culver City Democratic Club

[Editor's note: On April 28 the Los Angeles County Board of Supervisors voted unanimously to send vote-by-mail ballots to every voter registered for the November general election.]

Resolution on Ballot Design in the November 3 Election

WHEREAS, The Primary Election of March 3, 2020 was characterized by voting screens not working properly, long lines, long waiting periods at the new voting centers; and

WHEREAS, candidates running for the same office were placed on different pages with the result that voters could have missed voting for some of the candidates if they had not pressed the "more" button on their voting screens; and

WHEREAS, voters who registered to vote by mail did not receive their ballots in time and had to drive to Norwalk to vote early; now, therefore, be it

RESOLVED, That the Culver City Democratic Club urges the Los Angeles County Registrar-Recorder/County Clerk to allow all eligible voting residents of the County of Los Angeles to vote by mail in the November 3, 2020 election to avoid the technical problems encountered in the March 3 election; and be it further

RESOLVED, That Culver City Democratic Club urges that the Los Angeles County Registrar-Recorder/County Clerk list the names of the candidates running for the same office on the same page of the ballot, just as it was done for the Presidential candidates, so that the voters can view and evaluate ALL the candidates at the same time.

Resolution on Vote-By-Mail in the November 3 Election

WHEREAS, Governor Gavin Newsom has decreed a Stay-At-Home social distancing advisory to slow down the rate of infection with the coronavirus COVID-19 in order not to overwhelm our hospitals and our inventory of personal protective equipment (PPE) stockpiles; and

WHEREAS, COVID-19 has been compared to one of its coronavirus pandemic predecessors, the Spanish Flu that occurred between 1918 and 1920, we must prepare for the current pandemic to last months rather than weeks in realistic terms; and

WHEREAS, COVID-19 can be spread by everyone pushing the same buttons when voting and congregating in one place without maintaining the recommended six feet separation; now, therefore, be it

RESOLVED, That the Culver City Democratic Club urges the Los Angeles County Registrar-Recorder/County Clerk to mandate all eligible voters in Los Angeles County to vote by mail in the November 3, 2020 election to protect the health of the County's residents and poll workers; and be it further

RESOLVED, That, when passed, this resolution be distributed to all the Democratic Clubs chartered by the Los Angeles County Democratic Party, to California Secretary of State Alex Padilla, and to Los Angeles County Registrar-Recorder/ County Clerk Dean Logan.

The following resolution is presented for consideration by the Culver City Democratic Club

Resolution to Protect and Preserve the Ballona Wetlands Ecological Reserve

Whereas, the California 2010 Code of Regulations reiterates State's policy "to protect threatened or endangered plants, wildlife... or specialized habitat types... for the future use of mankind through the establishment of ecological reserves;" and

Whereas, California spent \$140M of public funds in 2004 to acquire 607 acres of rare, biodiverse, freshwater wetlands and associated habitats; placed them under the State's protection by establishing the Ballona Wetlands Ecological Reserve (BWER); and appropriated an additional \$25M of public funds to be used within three years for planning (\$2M) and restoration (\$23M); and

Whereas, the Ballona Wetlands Ecological Reserve is a natural gem, that provides rare habitats for migrating birds; a safe haven for a diversity of year-round inhabitants including rare and endangered bird and animal species; abundant flora; a food source for pollinators reliant upon seasonal wetlands diversity, rare grassland and upland habitat; and soil/subsoil carbon sequestering microbiomes; and

Whereas, the Ballona Wetlands Ecological Reserve and the State Lands Public Trust Freshwater Marsh are the last vestiges of over two thousand acres of rare, historic, seasonal freshwater wetlands; BWER needs rehabilitation from past challenges to its ecosystems integrity that included agriculture; dredging out of the Ballona Flood Control Channel and Marina del Rey (a saltwater habitat); commercial/residential development including Playa Vista; ongoing oil/gas exploitation; and

Whereas, seventy-eight years of underground gas storage in BWER have given rise to migrating/escaping toxic gases contaminating the environment; threatening public and ecological health and safety; requiring remediation and monitoring by private fossil fuel interests and commercial/ residential development, and monitoring by the city of Los Angeles and the State; and

Whereas, systematic corporate groundwater pumpingout policies have dewatered the BWER since its creation, violating the Coastal Act; freshwater continues to be diverted from Ballona, while the California Constitution mandates that groundwater be managed sustainably for environmental benefit (SB-1168, Pavley. Groundwater management); and

Whereas, the California Department of Fish and Wildlife's (CDFW) Final Environmental Impact Report (FEIR) would violate precautionary "DO NO HARM" fundamental principles of conservation, by:

1. Removing Ballona Channel levees that protect the wetlands;

2. Exposing Ballona to rising seas, higher tides, contaminated/toxic superstorm runoff;

3. Flooding approximately 65%, or 400 acres, of the Ecological Reserve with millions of gallons of increasingly acidified seawater;

4. Contaminating underlying freshwater aquifers with saltwater intrusion;

5. Excavating five million tons of soil with its habitat and seed bank;

6. Destroying abundant flora and fauna;

7. Removing approximately 20% of current wildlife habitat by blanketing 120 acres of habitat with 5 miles of 25-30-foot-high/200-foot-wide levees; US Army Corps of Engineers levee regulations disallow deep-root system growth and employ Vector Control to prevent burrowing animals, prohibiting levees from being used as habitat;

8. Obstructing wetland views, including in the Coastal zone; and

Whereas, the CDFW's FEIR would violate sacred sites of the Tongva indigenous people who lived in Ballona for 10,000 years; causing the destruction of ancient settlements and gravesites, thereby violating principles of human rights and environmental justice; and

Now, therefore, be it resolved that Culver City Democratic Club supports:

1. Protecting the Ballona Wetlands Ecological Reserve as a community-engaged restoration that honors "DO NO HARM" restoration principles preserving the land, water, and species dependent on this threatened ecosystem where birds and other wildlife require every acre in order to survive;

2. Protection from fossil fuel interests who threaten Ballona's environment and the public's health, safety, and well-being;

3. Returning Ballona's freshwater to the BWER, opposing further drainage, diversion, and throw-away of its life-giving freshwaters;

4. Opposing the industrial scale bulldozing, demolition, and conversion of Ballona Wetlands into a full saltwater tidal bay;

5. Standing in alliance with environmental justice principles and policies that protect the sacred sites of indigenous peoples, such as the sites of the Tongva within the Ballona Ecological Reserve.
