President's Message by Jeff Schwartz

How to buy a Democratic club

Fellow Democrats.

This newsletter will arrive a week before general election voting closes. I expect that anyone who would open this message and read this spiel is highly politically engaged and voted weeks ago, but if not, don't forget! Details are at Lavote.net. You can complete your ballot at home and mail it, drop it in one of the special boxes around town (I used the one at the Culver City Library) or at a vote center, or vote live at the vote center.

I hope you found our endorsements useful, and I encourage you to share them and other progressive voter guides with your friends and neighbors. As I mentioned last month, our Club is the only westside organization I know of which chooses its endorsements by a direct vote of the membership, without recommendations from an endorsement committee. All Democrats running appear equally on our endorsement ballot, and all members in good standing have an equal vote, whether they have been members for a month or a decade and whether they are \$20 Student members or \$500 Lifetime members. That's democracy: one person, one vote.

The recent LA City Council scandal has made me especially proud that this direct endorsement process is written into our bylaws. While the initial leaked recording continues to rightly dominate coverage because of the open bigotry on display and the discussion of gerrymandering to reduce the influence of political rivals, renters, progressives, and various ethnic groups, a second tape included a discussion by LA Federation of Labor staff about "buying" the endorsements of

various Democratic Clubs. I want to be clear that our process of endorsement by the entire membership, choosing from all Democrats running without the intervention of leadership or an endorsement committee, makes us unbuyable.

I look forward to a fuller investigation of the implications of this tape, but for now I will attempt to explain what this is about, as best as I understand it.

Does someone show up with a bag of cash, as in a mob movie, or at least <u>Bag Man?</u> That sort of thing is <u>not unknown at LA City Hall</u>, but I do not believe that is what they mean by "buying" Democratic clubs.


It is common for gifts to have strings attached: not a quid pro quo, but simply an expectation that an act of generosity will be remembered, nudge nudge, wink wink. This is why anonymity of both givers and receivers plays a major role in Maimonides' Ladder of Giving. This is definitely a way people and organizations are influenced, but it is not what the people on that tape were discussing.

Here is how I think this works: staff and

supporters of a particular candidate, official, organization, etc join a Club. This is completely legal and sound. For example, any registered Democrat is welcome to join our Club. There may be an issue if people are not paying for their own memberships: like any political contribution, dues need to be paid with your own money so that go-betweens aren't used to circumvent all sorts of campaign finance laws, from donation limits to bans on foreign contributions, but there is no maximum donation to our Club (or other PACs) and it isn't Putin who's buying local Democratic endorsements.

Once a few controlled members are in a Club, they volunteer for the endorsements committee. This is easy, because it is difficult to get people to serve on committees. It is not even necessary to have a majority to take over a committee, it's enough to be willing to do the work. Grassroots activists are stretched so thin, especially during election season, that a member who volunteers to make the questionnaires, schedule the candidate interviews, and draft the slate is met with

gratitude rather than suspicion. The slate this controlled member has made goes to the membership for approval with considerable procedural advantages, and all sorts of legal and/or deniable shenanigans are possible. For example, members of the endorsement committee could tell the slate candidates to rally their supporters for the relevant meeting and not let the non-slate candidates know their status in advance.

These maneuvers are not possible in our Club, because we do not have an endorsement committee and all endorsements are by a direct vote of the membership. It's the candidates and the members, no filter. We do have a nominating committee for Club officers, but

a majority of its members are chosen by the general membership, and all it takes to enter an opposing candidate for any office is a nomination and a second.

I do not know who wrote our bylaws. They are likely a collective work, not amended like the US Constitution, whose text is unchanged from what the Framers wrote, but periodically revised, most recently to add Article XVI on our grievance procedure, as mandated by the LA County Democratic Party. So, I can only offer my thanks to the past Club members and officers who wrote direct democracy into our endorsement process, the most important work of this organization. Few other groups can match our level of transparency and participation.

Most voters don't know all of this be-

hind-the-scenes business: before I was elected a delegate to the state party I did not know the difference between the DNC, DLC, DSCC, and DCCC, for example, but I believe the integrity of our process is reflected in our high reputation in the community.

This is also a great credit to all of you. We are entirely member-funded and volunteer-staffed. That's you. Memberships expire at the end of December, so renew now for 2023. Buy tickets for our Nov. 19 night at The Actors' Gang. Get our new t-shirts—they make great gifts. Consider volunteering for a committee. I am proud to have been entrusted with the leadership of this people-powered organization. Your participation makes it work.

As Locals Win Progressive Policies in Culver City, the Right-Wing Backlash Is Funded by Big Developers

The developer behind The Culver Studios is funding Culver City's right-wing groups to the tune of \$225,000.

The PAC's official name is a mouthful: "Alliance for Culver City to Support the Election of Denice Renteria and Dan O'Brien for city council 2022, Sponsored by The Culver Studios."

The last few years have seen a burgeoning progressive movement in Culver City translate electoral wins into enactment of progressive policies. The list includes permanent rent control, permanent tenant protections, a higher minimum wage, new protected bus and bike lanes, the closing of the Inglewood Oil Field, and even an initial study into local reparations.

As we head into the November elections, progressive policies are on the ballot: a higher tax on big businesses and local voting rights for 16- and 17-year-olds. But with two of the three seats held by the progressive majority up for election, it's possible that all this could be rolled back, and a resurgent right-wing back-

lash is looking to do just that, bankrolled by real estate developers.

Several new local political action committees (PACs) have sprung up to oppose newly passed progressive policies: Culver City Neighbors United, Common Sense Culver City, and Culver City Coalition. But one dominates the conversation: Protect Culver City.



Knock LA profiled Protect Culver City during the 2020 election.

Protect Culver City was founded by landlord and failed Republican congressional candidate Ron Bassilian, who used the organization as a vehicle to oppose the city's new rent control measures. Knock LA <u>investigated</u> Protect Culver City's origins and deemed it a "dangerous rightwing element in Culver City."

Protect Culver City was successful in getting an anti-rent-control measure on the 2020 ballot, and the California Apartment Association, the biggest landlord lobby in the state, put more than \$250,000 into the 2020 election in Culver City. The measure failed to pass and Culver City's permanent rent control ordinance is still in effect. In retrospect, this was a harbinger of real estate's outsized role in Culver City elections to come, as opposition to progressive change has spread through different groups using a diverse set of tactics: astroturfed "community" groups, clogging city hall with bogus records requests, failed recall campaigns, and sleazebag agitprop.

In 2021 a group of million-dollar homeowners formed Culver City Neighbors United in response to the city's proposal to allow multiple units on single family lots (rendered moot when the state <u>passed legislation</u> to similar effect). They rally homeowners to council meetings and arm them with talking points, generally in opposition to progressive policies.

A conspiracy-minded blog/PAC called Common Sense Culver City, which popped up in late 2021, makes public records requests and posts them alongside conservative dog whistles like appeals to "common sense." Following the backlash against Los Angeles Councilmember Mike Bonin and Los Angeles District Attorney George Gascón, conservative activists in Culver City also mounted a recall attempt. Early "Call to Recall" art initially targeted all three progressive councilmembers. But, perhaps anticipating the bad optics of trying to recall both of the city's first two Black councilmembers, Yasmine-Imani McMorrin and Mayor Daniel Lee, organizers behind the failed recall attempt narrowed their targets to Mayor Lee and Councilmember Alex Fisch.

After the failure of the recall attempt (without even turning in any signatures), the same interests reformed as Culver City Coalition. Culver City Coalition's first major expenditure came in 2022 in the form of a flyer titled "Save the Culver City Police Department," which asked residents to support the police at a city meeting where CCPD was seeking authorization from the city council to use military equipment including tear gas, MP5 submachine guns, and projectile launchers.

In a progressive place like Culver City, groups like these may be dismissed as fringe and irrelevant. But looking at the list of donors tells a different story.

On September 29, 2022, quarterly campaign finance filings revealed that the single biggest donor to all three PACs

(Culver City Neighbors United, Common Sense Culver City, and Culver City Coalition) is The Culver Studios, part of Hackman Capital Partners.

In other words, nearly all the different groups spending money to tell you to vote for Denice Renteria and Dan O'Brien are actually getting their money from the same place: one of the biggest developers in town.

But before we get to the extent of the real estate money funding the right-wing backlash, let's meet the candidates representing this movement. In addition to endorsing the lawless Sheriff Alex Villanueva, Protect Culver City endorsed Dan O'Brien and Denice Renteria for city council. O'Brien appeared for a meet-and-greet at a Protect Culver City meeting, and the group later praised his commitment to a "hands-on approach to transient camps." And in his interview with Common Sense Culver City, he touts his experience on the city's homelessness committee, where he instituted a policy of only offering food and services to unhoused people at the city's cold-weather shelter if they boarded a bus and left the city during the daytime.

Denice Renteria appeared alongside <u>a</u> Republican US Senate candidate at a Protect Culver City <u>fundraising dinner</u> in June 2022. At a <u>recent candidate forum</u> in September, Renteria advocated for a

return to "proactive policing," a practice that has incorporated <u>racial profiling</u> and has been shown to actually correlate with an <u>increase in the incidence of major crimes</u>. Protect Culver City also <u>calls</u> for the city council to end its "hands off" policy for the city's unhoused residents.

Two of Protect Culver City's school board candidates are even more overtly right wing. Marci Baun's first appearances at the school board were as part of the throngs of anti-vaxxers protesting the school district's vaccine mandate — she called for "health freedom" and claimed that "natural immunity is ... much better than the vaccine." Appearing at the Culver City Democratic Club school board candidate forum in August, Howard Adelman railed against "race-baiting, virtue-signaling, bile-spewing ideologues" and claimed that LGBT+ education in elementary school is <u>"indoctrinating"</u> <u>kids</u>. He is also the subject of a <u>restrain-</u> ing order for both assaulting a minor and harassing him with racial slurs. Darrel Menthe, the third school board candidate endorsed by Protect Culver City, is the president of the Culver City Downtown Business Association, and he keeps a relatively low profile compared to the other two. Real estate developers aren't just funding right-wing Culver City PACs — they're also giving to the candidates directly and forming their own PACs to get their candidates elected. Hackman Capital Partners (through its affiliate The Culver Studios Owner, LLC) dropped more than \$225,000 into a PAC explicitly to support two candidates: Denice Renteria and Dan O'Brien. This is almost half of the funding floating around this city council race, across all candidates and PACs. Even outside his PAC, Michael

Hackman, the CEO of Hackman Capital Partners, has nearly maxed out personal donations to Renteria and O'Brien.

And the other Hackman/Culver Studios-funded PACs are in the mix, too: Culver City Coalition promotes campaign events for O'Brien, Renteria, Baun, and Adelman; Common Sense Culver City regularly attacks Councilmember Fisch and candidate Freddy Puza; and Culver City Neighbors United currently has an ad endorsing O'Brien and Renteria.

This isn't the first time Hackman has drawn political controversy over its donations. In 2019, Hackman founded and funded Culver City Forward, a nonprofit that employed a sitting Culver City councilmember as its CEO.

Hackman is one of the biggest developers of studio and soundstage properties in the world — and they've got a substantial footprint in Culver City. Its significant political spending sends a clear message that Hackman wants to stop Culver City's government from being as progressive as its residents.

Looking at the campaign finance data and matching up donors to industries paints a stark picture: real estate money is a huge factor in this election. Even setting aside PAC money, real estate makes up 18.25% of the total dollars being contributed directly to the city council candidates. This category includes developers, realtors, mortgage brokers, landlords, architects, construction companies, and contractors.

As part of the questionnaire for the Culver City Democratic Club (CCDC) candidate forum, most of the City Council candidates took a pledge not to take developer money. That includes Renteria, who later took \$500 from Kent Company (which is part of the Continental Development Group), \$2,100 from executives at Redcar Properties, and \$1,050 from Michael Hackman, CEO of Hackman Capital Partners.

Overall, real estate makes up 15.71% of dollars contributed to Renteria. In contrast, real estate is 2.31% of dollars contributed to Alex Fisch and 1.89% of dollars contributed to Freddy Puza.

Dan O'Brien, who is not a registered Democrat and so did not participate in the CCDC forum, took no such pledge. Overall, real estate makes up 28.92% of his donations.

But there's more. It is illegal for an individual or a company to give more than \$1,070 to a candidate. But when you look at the data, you start to see that multiple people associated with the same real estate project are maxing out their contributions.

For example, the developer, architect, contractor, and law firm for the 9925 Jefferson Boulevard development together donated a total of \$8,280 to Dan O'Brien. The eight different contributions came in on just three days in late August.

In another case, \$2,970 came to Dan O'Brien from the developer Hudson Pacific Properties, together with members of its lobbyist firm M Strategic Communications. Hudson Pacific Properties owns the former NFL Network building at 10950 Washington Blvd, which is now vacant and may be redeveloped soon. Hudson Pacific Properties itself is owned in part by the private equity firm Blackstone.

Dan O'Brien, however, did sign a different pledge. He <u>promised</u> not to take more than \$200 from the corporate healthcare industry, including its lobbyists. Nevertheless, he took \$1,900 from lobbyists at M Strategic Communications, who <u>lobby for the healthcare giant Centene</u>.

to report returning any contributions.

So why is there such an interest in this five-square-mile town of little more than 40,000 people? It might be that when progressive policies are implemented, they tend to spread.


Take the Inglewood Oil Field. After Culver City made its landmark vote to start closing the oil field, the Los Angeles County Board of Supervisors took up the issue and approved an ordinance to phase out oil wells, and the city of Los Angeles is on the same path. And now Gavin Newsom has signed a bill to ban new drilling near homes, schools, and hospitals, effectively banning the activity from most developed areas in the state.

Other issues are catching on as well. The Los Angeles County Board of Supervisors is also looking to adopt permanent tenant protections two years after Culver City adopted the same. And the city of Los Angeles has <u>United to House LA</u> on the ballot — a real estate transfer tax that's slightly less ambitious than the one <u>Culver City</u> passed two years ago.

But looking back to Culver City's final vote on the oil fields issue in October 2021, only the three progressives voted to close the oil fields. The other two councilmembers — who have endorsed O'Brien and Renteria — abstained or voted against the ordinance. And so the

Despite pledging not to take more than \$200 from healthcare lobbyists, O'Brien took \$1,900 from lobbyists who represent a corporate healthcare company.

And even smaller right-wing causes are giving money to O'Brien and Renteria. Robert Retting of Culver City's notorious Martin B. Retting gun shop contributed to both campaigns. Unlike in past elections, where more conservative candidates like Albert Vera tried to strike a moderate stance by returning Retting's donation, O'Brien and Renteria have yet

big money coming into our little city has the potential to stop the progressive tide in its tracks.

Whenever the votes are done being counted, we'll find out if our election is the way these developers see it: no different than a piece of real estate, for sale to the highest bidder.





The City Council took major steps towards this vision during Alex's first term: phasing out oil production within city limits, expanding tenants' rights, providing emergency rental assistance, substantially reducing the city's structural deficit, expanding outreach to the unhoused, winning a Project Homekey grant to convert two motels into housing for those most in need, and approving the creation of a mobile crisis response service. During the pandemic, the council moved quickly to assist residents with necessities like meal delivery and regular phone calls to seniors while assisting businesses with expanded outdoor dining, fee waivers, and tax deferrals.

Alex represents the City on the Westside Cities Council of Governments (the COG), and represents the COG on the Regional Council of the Southern California announced that he will not run for a second term. There are two openings on the Council this year. Both Alex Fisch and Freddy Puza are long-time members of the Culver City Democratic Club.

Association of Governments. His regional work has helped Culver City win grants from the Biden Infrastructure Bill, various state environmental, housing, and mobility programs, Olympic funding, and regional opportunities.



Vote YES on County Measure A

On July 12, LA County Supervisor Holly Mitchell issued the following press release and began the process of putting a charter amendment on the November ballot. It would give the supervisors the power to remove the LA Sheriff for cause by a vote of at least four of the five supervisors. The Culver City Democratic Club endorsed this charter amendment, County Measure A, by more than 87 percent.

I attended the Club meeting in 2018 when we endorsed the current sheriff. He spoke and took questions for what seemed like the better part of an hour, and the members voted overwhelmingly to back him in the election. That turns out to have been a big mistake. He presented himself as a reformer. He is not. He reminds me a bit of Donald Trump, I listened to him last night at a meeting of the Santa Monica Democratic Club as he railed against those whom he considers his enemies, repeatedly accusing them of corruption. LOS ANGELES, Calif. — The Los Angeles County Board of Supervisors today approved the initiation of the process of amending the County Charter to meet the structural need for increased accountability of the Los Angeles County Sheriff. The motion authored by Chair Holly J. Mitchell and co-authored by Supervisor Hilda L. Solis directs County Counsel to draft an ordinance for a special election that will allow voters to decide on an amendment to the County Charter that would grant the Board of Supervisors the authority to remove a Sheriff who violates the law or abuses power by a four-fifths vote.

"The State Legislature, the Board and voters have gone to great lengths to create a system of accountability and transparency. However, for decades, the current system has allowed abuses of power to thrive largely unchecked with serious consequences for public safety. It has become painfully clear that the Board must put this question to the voters. The proposed Charter amendment would allow the Board to expeditiously remove a Sheriff who violates the law," said Los

Angeles County Board of Supervisors Chair Holly J. Mitchell, representing the Second District. "Under the current system, voters must wait for a grand jury to convene or a recall election to be held. The voters deserve an opportunity to decide whether this is the right way to enhance accountability of the Sheriff and protect the lives and liberties of County residents."

"Accountability over law enforcement is public safety," said Los Angeles County Supervisor Hilda L. Solis, First District. "Ensuring our residents have the ability to vote on being free from law enforcement intimidation, harassment, and misconduct and holding them accountable for any ensuing harm and trauma is the Board of Supervisors' responsibility, specifically over the Sheriff of Los Angeles County. This charter amendment would provide residents with the oversight they expect and the peace from law enforcement abuse they deserve."

The California Constitution authorizes county charters to provide steps for the removal of county officers, including an elected sheriff. As a charter county, LA County requires a Charter amendment to be approved by voters. With voter approval, the County would create a process by which the Board of Supervisors could vote to remove a Sheriff for cause only, with grounds for removal including: a violation of any law related to the performance of Sheriff duties; flagrant

or repeated neglect of duties; a misappropriation of public funds or property; willful falsification of a relevant official statement or document; or obstruction of any investigation into the conduct of the Sheriff by the Inspector General, Sheriff Civilian Oversight Commission, or any government agency with jurisdiction to conduct such an investigation.

"The county has a history of sheriffs who break the law and ignore — or worse, facilitate — deputy misconduct. The public demanded that the Board act on its duty to supervise the Sheriff and protect people in the most vulnerable circumstances. The Board heard us, and it did." said Melanie Ochoa, Director of Police Practices at the ACLU of Southern California. "No matter who wins in November, structural change is needed to make sure that we don't have another sheriff with a \$3 billion budget, unlimited weapons, and no real process to achieve accountability while lives are at stake."

The motion preserves the public's right to vote and elect a Sheriff and will not impact the independent investigative and prosecutorial function of the Sheriff. The first directive of the motion instructs County Counsel to present a draft ordinance to call a special election on Tuesday November 8, 2022. The draft ordinance will come before the Board for at least two readings before receiving final approval to be placed on the ballot. The first review and vote for approval of the ordinance by the Board of Supervisors will take place at the Tuesday July 26, 2022 public board meeting.

Mike Davis 1946-2022


As the deadline for this newsletter arrived, it was announced that author and activist Mike Davis had died. He had been on hospice for several months, so this was no surprise, but it is a major loss to progressive politics, cultural studies, and Southern California. Carolina Miranda has written a tribute in the LA Times and I expect there will be many more.

Davis transformed my understanding of Los Angeles with *City of Quartz* (1990), *The Ecology of Fear* (1998), and his final magnum opus, written in collaboration with Jon Weiner, *Set the Night on Fire* (2020).

His work also helped inspire the contemporary left by drawing historical and theoretical links between the Old Left of Dorothy Healey and Harry Hay, the New Left of SDS and the Black Panthers, and the postmodernism of Frederic Jameson and Andrew Ross.

He leaves behind a shelf of books and a powerful example. —Jeff Schwartz



What you need to know about Measure BL

Updating Culver City Business License Tax Rates







The Culver City Democratic Club recommends a YES vote on Measure BL

What is a business license tax and who pays it?

Every business operating in the City is required to file a Business License Tax application before opening up shop and to pay the annual tax each year thereafter.

The following businesses and organizations are required to obtain a business tax certificate and any necessary permits; however, they are not required to pay a business tax: charitable organizations; parks, recreation & community services contractors; employees (whether on salary, commission, or other compensation basis); and homeowners' associations.

How does Measure BL affect local business owners?

If voters approve Measure BL, approximately 6,000 businesses will no longer pay the annual business license tax, due to the \$200,000 gross receipts exemption. Businesses whose annual gross receipts exceed \$200,000 could pay a higher or lower business license tax, depending on their business type and gross receipts.

How does Measure BL affect the Culver City community?

Business license tax revenue is a part of the General Fund and can be used for any general City expense. If voters approve Measure BL, revenue from the measure could generate approximately \$10 million annually (until ended by voters) that stays within the City and would require annual independent audits. The City could use this revenue for services such as emergency response, maintaining parks, and addressing homelessness.

What will Measure BL say on your ballot?

"Shall the measure updating Culver City's business license tax to either a flat tax up to \$1,000, or 0.13%-0.35% of gross receipts (depending on business type), 4% for oil well operations, and an additional 0.01% for gross receipts over \$100,000,000, exempting the first \$200,000 in gross receipts, updating business classifications, generating approximately \$10,000,000 annually, until ended by voters, for such general fund services as emergency response, parks, homelessness services, and requiring annual independent audits, be adopted?

Updating Culver City Business License Tax Rates



The business license tax rate structure is based on either gross receipts or a flat rate tax depending on the type of business activity.

CURRENT - ranging from 0.1% - 0.3%

Depending on business classification -0.1% - 0.3%Oil well operations tax rate -1.8% or \$18/\$1,000 Flat tax up to \$720

No tax exemption on gross receipts

PROPOSED - ranging from 0.13% - 0.35%

Depending on business classification - 0.13% - 0.35%

Oil well operations tax rate -4.0% or \$40/\$1,000

Flat tax up to \$1,000

Tax exemption on the first \$200,000 in annual gross receipts for businesses whose tax rate is based on gross receipts

Additional tax of 0.01% or \$0.10/\$1,000 on gross receipts more than \$100 million

Are there exemptions to the proposed business license tax?

Yes, if voters approve Measure BL, approximately 6,000 businesses will no longer pay the annual business license tax, due to the tax exemption on the first \$200,000 in annual gross receipts for businesses whose tax rate is based on gross receipts.

When would Measure BL go into effect?

If approved, Measure BL would go into effect on April 1, 2023 for all new businesses. Businesses currently active in Culver City would not be impacted until the 2024 business license tax renewal period, which is due no later than February 2024.



Did You Know?

Culver City has not updated business license tax rates since 1965.

Measure VY (Votes for Youth) would allow 16-yearolds in Culver City to vote in local elections

We are a youth-led campaign to lower Culver City's voting age to 16 in municipal and school board elections. Vote16 CC is a derivative of the larger Vote16 movement, which has chapters in cities across the country. Our leadership team is the fourth to come through this chapter. Measure VY will be voted on in the upcoming Culver City General Municipal Elections on November 8.

Initial reactions to our movement are often immediate and negative. This is understandable; allowing 16-year-olds to vote in local elections appears as an unfamiliar and seemingly dramatic change. However, youth empowerment is the way forward. Eighteen became the national voting age only relatively recently during the 1970s. It can change to fit the priorities and attitudes of our community, and will ultimately lead to fairer elections that represent public interest.

So, why should you support our right to vote?

By the age of 16, people have developed what is called "cold cognition." While "hot cognition" (impulsive, emotional, short-term decision making) is usually associated with teenagers, most of us have also developed "cold cognition" (logical, reasonable, long-term decision making) by this age. Sixteen-year-olds are asked to make decisions about their futures—are they not capable enough of making decisions about their political environment?

Sixteen-year-olds are immeasurably impacted by local legislation. The school board has a direct hand in our day-today lives. We can work and live in Culver City, so elements like transportation, policing, and city planning impact us daily, too. And as future residents, we will be uniquely affected by climate change. Our perspective should be represented. This is not to say that youth voices are not being listened to. If anything, the status of teens as an important group has improved over the past few years. However, this should not be confused or conflated with the protections and powers provided with actual voting rights for 16- and 17-year-olds. We should have a say when

these matters directly affect us.

As for education: in some ways, teenagers are better equipped than adults to be competent voters. Where most people over the age of 18 have been out of school for years at the time of the election, teens as students regularly receive an up-to-date education in civics and community responsibility in the classroom. In fact, students must take a class on American government in order to graduate.


Moreover, voting at a young age creates life-long voters. However, most people do not vote in their first election. Giving teenagers the right to vote in local elections at a time when they have structure and familiarity in their lives will encourage voting and increase turnout. It would present a more accurate sample of public opinion. Lowering the voting age to 16 will help create a generation of habitual voters. There is a lot of concern over the viability of our political ideology. The truth is that we form our beliefs the same way everybody else does. This has never been more true than it has been over the past few years. We look at the world and see the ways in which we want it to reflect our needs. Since we cannot vote, we organize protests, action groups, and campaigns to represent our interests. Students are one of the primary groups of individuals who have shown an invested and passionate interest in local politics. From school shootings and gun protections; police violence and racial discrimination; to education and historical bias, we have legitimate perspectives based on the ways in which these issues impact us daily. Belittling the importance of the youth voice is a form of suppression. It's a way to ignore the actual wants of the people. Minimizing our role as a portion of Culver City's population that deserves equal respect is a way to ensure that our local political scene does not represent all stakeholders and only upholds the status quo.

Extending the municipal vote to 16- and 17-year-olds is one step towards fair representation. It is one step towards progress. It is one step towards a vision of tomorrow that matches our priorities as a community.

Culver City voters will be able to vote on Measure VY in November. We have garnered endorsements from prominent Culver City figures such as Mayor Daniel Lee, City Council Member Alex Fisch, School Board President Dr. Steven Levin, and others. But we need your support to vote for our measure, help us raise funds, and change the Culver City community for the better.

To expand the voting age to 16 in Culver City's school board and municipal elections.

- 1. Creating a generation of habitual voters: The primary factor affecting voter turnout is the social environment of first-time voters (University of Copenhagen). Those who first cast a ballot in their familiar community, versus those who have moved for college or work, are more likely to become habitual voters.
- 2. Increasing civic engagement: Voting in one election can increase the probability that a person will vote in the next election by over 50 percent (American Journal of Political Science, 2003).
- 3. Promoting responsibility from a young age: 16- and 17-year-olds will directly apply their knowledge from manadatory civics classes and their experience being affected by local issues (like emergency services, rent control, parks, school board decisions, and the Inglewood Oil Fields) when casting their vote.


